**I. OPENING ITEMS**

- A. Call to Order** – President David Styer called the meeting of the Board of Education of the School District of the Menomonie Area to order at 5:30 p.m. on Monday, October 11, 2021, in the Auditorium of the High School in Menomonie, Wisconsin.
- B. Roll Call and Quorum** – Roll call showed eight board members present: Tanya Husby, Clint Moses, Karl Palmer, Amy Riddle-Swanson, Angie Skillings, Mark Hillman, Charlie Schneider and David Styer. Chris Freeman was absent. President Styer declared a quorum and noted that the meeting had been duly noticed. - J. Monthly Employment Report (September 2021)** - The board reviewed the monthly non-certified staff employment report for September 2021, which included 1 transfer, 1 expanded, 4 new hires and 2 resignations.

#### IV. ACTION AGENDA


- A. Action to Approve Optional Masking Policy for Grades 4K-12** - Skillings made a motion, seconded by Moses, that the board approves optional masking policy for Grades 4K-12, as presented. Skillings made a motion to suspend the rules, seconded by Moses. The motion to suspend the rules failed with a 4-4 vote with Riddle-Swanson, Styer, Schneider, and Palmer casting “nay” votes. Motion to approve optional masking for Grades 4K-12 failed with Riddle-Swanson, Styer, Husby, Schneider and Palmer casting “nay” votes.
- B. Approve 2022 Health Insurance Renewal** - Palmer made a motion, seconded by Schneider, that the board approve the 2022 renewal for district health insurance, as presented. The motion passed by a unanimous electronic vote.
- C. Approve Final Budget Revisions for 2020-2021** - Hillman made a motion, seconded by Husby to approve the final budget revisions for 2020-2021, as presented. The motion passed by a unanimous electronic vote.

#### V. DISCUSSION ITEMS/POLICY REVIEW

- A. Early College Credit Requests for Spring 2022** – Dr. Zydowsky and Assistant Superintendent of Instruction, Brian Seguin, provided an overview of Early College Credit Requests for Spring of 2022. It is not uncommon for individual students to make multiple requests for college credits based on unknown course availability at the post-secondary level. Students may take up to two courses. Early College Credit requests for spring 2022 were presented to the board. There were 253 requests for courses by 34 students.
- B. 2021-2022 Budget Timeline** – Dr. Zydowsky shared the timeline for developing the 2021-2022 budget and reminded school board members they will be considering the budget and setting the tax levy at the school board meeting on Monday, October 25, 2021.
